4. The corporation shall have the authority to issue 5,000 shares of common stock, in one class only, each with a par value of \$ 0.10.


5. The registered agent of the corporation is Michael D. Pasek and the registered address is 4851 85th Avenue, Pinellas Park, FL 33781.

The number of directors may be raised or lowered by amendment of the bylaws of the corporation but shall in no case be less than one.


