
As we discussed on the telephone today, a timely filing of the Uniform Business Report was made in April of last year on behalf of our above referenced client, Roto-Hitch, Inc. It is our understanding that the Department attempted to return the report for the purpose of providing an Federal Employer Identification Number or to indicate its inapplicability. This attempted return by the Department never reached this firm or the client.

Given that the Department had received and deposited the filing fee remitted by this firm at the time of the filing of the report, as reflected by the check having cleared the trust account of this firm on the 16th of May 2001, it was presumed, obviously incorrectly, that the annual report filing had been properly accomplished.
