ARTICLES OF INCORPORATION

OF

THREE MASTERS ELECTRICAL CORPORATION

ARTICLE I

NAME

The name of this corporation is:

Three Masters Electrical Corporation



ARTICLE II

DURATION

This corporation is to exist perpetually. It shall commence its existence upon the signing of these Articles of Incorporation by the initial subscribers.
