**AMENDMENT OF
ARTICLES OF INCORPORATION
OF
ORLANDO.COM, INC.

Pursuant to the provisions of Section 607.1006, Florida Statutes, ORLANDO.COM, INC., a Florida corporation (the "Corporation") adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: Article I of the Corporation's Articles of Incorporation has been amended to read as follows:

"ARTICLE I.

The name and address of this Corporation shall be VSSL, INC., 1725 University Drive, Suite 450, Coral Springs, Florida, 33071, with the privilege of having its offices and branch offices at other places within or without the State of Florida."

SECOND: The foregoing amendment was adopted on May 10, 2002.
