**ARTICLE I - NAME OF CORPORATION**

The name of this corporation is J.V. ACTION TRANSPORT, INC.

**ARTICLE II - PURPOSES**

This corporation is organized for the purpose of transacting any or all lawful business pursuant to the provisions of Chapter 607, Florida Statutes.

**ARTICLE III - CAPITAL STOCK**

The maximum number of shares this corporation is authorized to issue is 4,000 shares all of which shall be common shares. 
