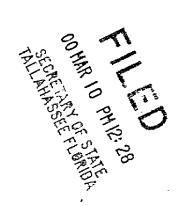

## ARTICLES OF INCORPORATION

OF

QUALITYMEDIA.NET, INC.



#### ARTICLE I - NAME

The name of this corporation is QualityMedia.Net, Inc., which has an initial principal place of business at 3799 Brantley Place Circle, Apopka, Florida 32703.

## ARTICLE II - COMMENCEMENT AND DURATION

The corporate existence of this corporation shall commence on the date of filing the same and shall have perpetual existence.
