ARTICLE I - NAME

The name of this corporation is QualityMedia.Net, Inc., which has an initial principal place of business at 3799 Brantley Place Circle, Apopka, Florida 32703.

ARTICLE II - COMMENCEMENT AND DURATION

The corporate existence of this corporation shall commence on the date of filing the same and shall have perpetual existence.

ARTICLE III - PURPOSE

This corporation is organized for the purposes of transacting internet media and communication services and for any or all other lawful purposes.

ARTICLE IV - CAPITAL STOCK

ARTICLE VII - INITIAL BOARD OF DIRECTORS


This corporation shall have five (5) directors initially. The number of directors may be either increased or diminished from time to time pursuant to the by-laws.


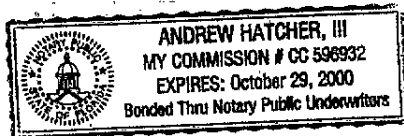


