**ARTICLE ONE. NAME**

The name of the corporation is JOE'S QUALITY AUTO REPAIR, INC.

**ARTICLE EIGHT. INCORPORATOR**




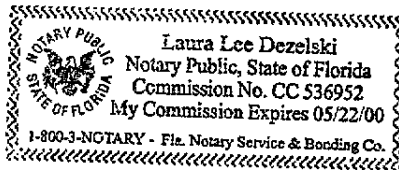
