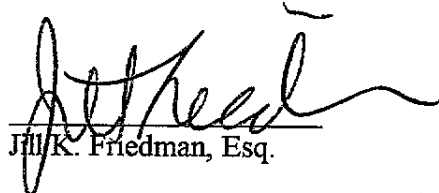

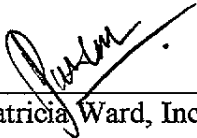
The number of directors may be raised or lowered as prescribed by the bylaws of the corporation but shall in no case be less than one (1).

This corporation is organized for the purpose of transacting any and all lawful business permitted under the laws of the United States and of the State of Florida. This corporation shall have perpetual existence.

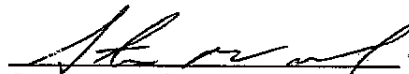
