

**ARTICLES OF INCORPORATION  
FLORIDA BUSINESS CORPORATION ACT**

Pursuant to chapter 607 of the Florida Business Corporation Act, the undersigned incorporators adopt these articles of Incorporation for the purpose of forming a for-profit corporation.


