The undersigned, in order to form a corporation for the purposes hereinafter stated, by and under the provisions of the laws of the State of Florida, does hereby subscribe to these Articles of Incorporation.

ARTICLE I - NAME

The name of this corporation is:

ARTICLE II - DURATION

This corporation shall have perpetual existence. The corporate existence commences on March 10, 2000.

- D. To engage in any or all lawful activity and to institute,

 enterprises and operations, and for the purposes of transacting any or all
 lawful business.

ARTICLE IV - CAPITAL STOCK
