**ARTICLES OF INCORPORATION
FOR

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, adopt the following Articles of Incorporation:

ARTICLE ONE

NAME

The name of the corporation is HULSE HOLDINGS, INC.

CORPORATE DURATION

The duration of the corporation is perpetual.

PURPOSE OR PURPOSES

The general purposes for which the corporation is organized are:

ARTICLE FIVE

CAPITALIZATION

The total number of shares of stock which the corporation is authorized to issue is ten thousand (10,000), all of which shall be Common Stock, and with a par value of One Dollar (\$1.00) per share. All Common Stock shares shall be identical with each other in every respect and the holder of Common Stock shall be entitled to one vote for each share on all matters on which shareholders have the right to vote.

ARTICLE SIX

PREEMPTIVE RIGHTS

The holders of shares of the corporation shall have preemptive rights to subscribe or purchase from the corporation any shares authorized but unissued, or any newly authorized shares.

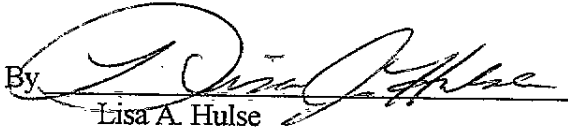
CONSENT TO SERVE AS REGISTERED AGENT
