

ARTICLE IV



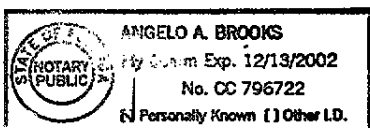


