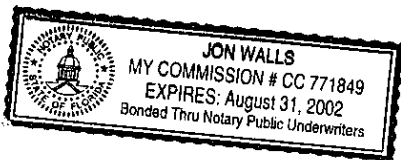
1. Maureen Archambault is the President of TJA POLICE PRODUCTS, INC., a Florida corporation, (hereinafter "Corporation").
