#### ARTICLE I - NAME

The name of this corporation is CONCETTA GIULIANO, D.O., P.A.

#### ARTICLE II - DURATION

This corporation shall have perpetual existence.

#### ARTICLE III - PURPOSE

The purposes for which this corporation is formed are:

- a. To engage in the practice of medicine as a professional corporation and to own or lease and operate medical facilities for the purposes of providing radiology services.

The Section is intended to expand the ability of the corporation to conduct business with interested parties and shall not be construed to invalidate any contract of other transaction that would otherwise be valid under the common and statutory law applicable to it.
