


**ARTICLE X. INDEMNIFICATION**



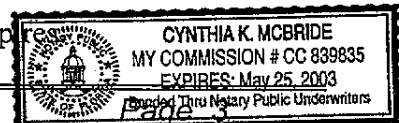


