# ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF POWER LINE ACQUISITION COMPANY, A Florida Corporation (Document No.: P00000027862)



Pursuant to the Florida Business Corporation Act, Section 607.1006, the undersigned corporation does hereby adopt the following articles of amendment to its articles of incorporation:

- 1. The name of the corporation is Power Line Acquisition Company (Document Number P00000027862).
