ARTICLES OF INCORPORATION

OF

ARTICLE I - NAME

The name of this Corporation is Beverage Law Consultants, Inc.

ARTICLE II - DURATION

The Corporation shall have perpetual existence.

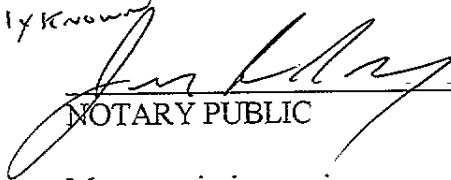
