**ARTICLES OF INCORPORATION  
OF  
BKR CONSULTING, INC.**

**ARTICLE I**

**Corporate Name and Principal Office**

The name of this corporation is **BKR Consulting, Inc.** and its principal office and mailing address is 21 9<sup>th</sup> Street South, Suite 201, St. Petersburg, FL 33705.

**ARTICLE II**

**Commencement of Corporate Existence**

The corporation shall come into existence on March 6, 2000.

**ARTICLE III**

**General Nature of Business**

This corporation may engage in any activity or business permitted under the laws of the United States or of the State of Florida.

**ARTICLE IV**

**Capital Stock**

The aggregate number of shares of capital stock that this corporation shall be authorized to have outstanding at any one time shall be one hundred million shares of common stock at \$.0001 par value per share and fifty million shares of preferred stock at \$.0001 par value per share. Each share of issued and outstanding common stock shall entitle the holder thereof to participate in all shareholder meetings, to cast one vote on each matter with respect to which shareholders have the right to vote, and to share ratably in all dividends and other distributions declared and paid with respect to the common stock, as well as in the net assets of the corporation upon liquidation or dissolution.

**ARTICLE V**

**Initial Registered Office and Agent**

The street address of the initial registered office of the corporation shall be 21 9<sup>th</sup> Street South, Suite 201, St. Petersburg, FL 33705, and the initial registered agent of the corporation at such address is Brendon Rennert.

## ARTICLE VI

### Directors and Officers

The business of this corporation shall be managed by its Board of Directors. The number of such directors shall not be less than one (1) and subject to such minimum may be increased or decreased from time to time in the manner provided in the By-Laws. The Board of Directors shall be elected by the Stockholders of the corporation at such time and in such manner as provided by the By-Laws.
