ARTICLES I – NAME

The name of the corporation shall be Jeff Parker Masonry, Inc.

ARTICLE II – DURATION

This corporation shall have perpetual existence and shall commence upon filing hereof.

ARTICLE III – PURPOSE

This corporation is organized for the purpose of general masonry construction and for all other purposes as allowed under County, State and Federal laws.

The name and address of the Incorporator is Jeff Parker, P.O. Box 324, Summerland Key, FL 33042


ARTICLE IX – OFFICERS

ARTICLE X – SUBCHAPTER S


This corporation shall be a Subchapter S, "Small Business Corporation," as that term is described by


