ARTICLES OF INCORPORATION
OF
NATASHA MOTEL, INC.

I, the undersigned subscriber to these Articles of Incorporation, being a natural person competent to contract, hereby subscribe to and form a corporation for profit under the laws of the State of Florida.

ARTICLE I

The name of the corporation is **NATASHA MOTEL, INC.**.

ARTICLE II

The principal place of business and mailing address of this corporation shall be 1509 East Hillsborough Avenue, Tampa, Florida 33610. The Directors may from time to time designate such other address and place for the principal office of the corporation, as they deem appropriate.

The corporation may engage in any activity or business permitted under the laws of the United States and the State of Florida.

RAJESH KUMAR, 1509 East Hillsborough Avenue, Florida 33610 is hereby designated REGISTERED AGENT upon whom process may be served.


