**ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION
OF
CARLOS L. DE ORDUNA, M.D., INC.**

Pursuant to Sections 607.1003 and 607.1006 of the Florida Business Corporation Act, the Articles of Incorporation of **CARLOS L. DE ORDUNA, M.D., INC.** a Florida professional corporation (the "Corporation"), are hereby amended according to these Articles of Amendment:

FIRST: The name of the Corporation is **CARLOS L. DE ORDUNA, M.D., INC.**

SECOND: "Article I. Name" of the Articles of Incorporation is amended in its entirety to read as follows:

"ARTICLE I

NAME: The name of the Corporation is **CARLOS L. DE ORDUNA, M.D., P.A.**

THIRD: The purpose of the Corporation pursuant to Chapter 021, Florida Statutes, is to practice medicine as permitted under the laws of the United States and Florida.

FOURTH: The foregoing amendment was adopted by written consent of the sole Shareholder on September 21, 2010, constituting a sufficient number of shareholder votes to approve the amendment.
