ARTICLE I. NAME

The name of the corporation is Joe Willis & Son Farm, Inc.

ARTICLE II. PRINCIPAL OFFICE

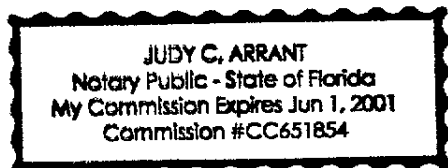
