Name**

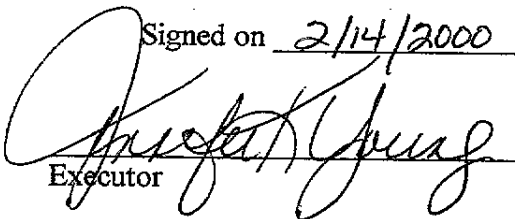
