## ARTICLES OF INCORPORATION

OF

The undersigned incorporator hereby forms and organizes a corporation for profit under the laws of the State of Florida.

### ARTICLE I - NAME

The name of the corporation is SUNLINE TRANSPORTATION COMPANY.

### ARTICLE II - DURATION AND COMMENCEMENT OF EXISTENCE

This corporation shall have perpetual existence. The corporation shall commence existence at 12:01 P.M. on March 20, 2000.

### ARTICLE III - NATURE OF BUSINESS

The corporation may engage in any activity or business permitted under the laws of the United States and of this State.

### ARTICLE IV - CAPITAL STOCK

The maximum number of shares of stock this corporation is authorized to have outstanding at any time is 100,000 shares of common stock, having a par value of \$.01 per share, fully paid and non-assessable.

Authorized capital stock may be paid for in cash, services, or property, at a just value, but not less than par value, to be fixed by the Board of Directors of this corporation.

Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his pro-rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

#### ARTICLE V - REGISTERED OFFICE AND AGENT

The street address of the initial registered office of the corporation 16477 53rd Road, Wellborn, Florida 32094.

The initial registered agent of the corporation at such office is Lester Louramore.

#### ARTICLE VI - DIRECTORS

This corporation shall have one (1) director initially. The number of directors may be increased or decreased from time to time as provided in the By-Laws, but shall never be less than one (1).

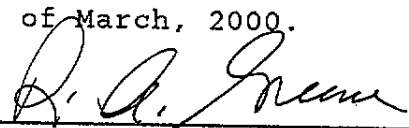
ARTICLE IX - AMENDMENT

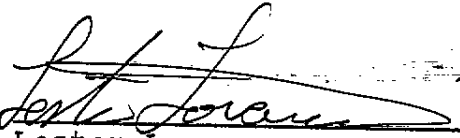

Every amendment shall be approved by the Board of Directors, proposed by them to the stockholders, and approved at a stockholders' meeting by a majority of the stock entitled to vote thereon, unless all the directors and all the stockholders sign a written statement manifesting their intention that a certain amendment of these Articles of Incorporation be made.

ARTICLE X - CUMULATIVE VOTING

At each election for directors every shareholder entitled to vote at such election shall have the right to cumulate his votes by giving one candidate as many votes as the number of directors to be elected at that time multiplied by the number of his shares, or by distributing such votes on the same principle among any number of such candidates.

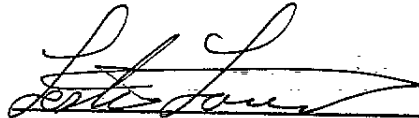
