ARTICLE I. NAME

The name of this corporation is: DAVID FENTON, INC.

ARTICLE II. DURATION

This corporation shall have perpetual existence commencing upon the filing of these Articles.

ARTICLE III. PURPOSE

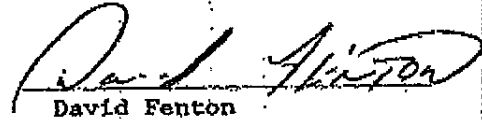
ARTICLE IX. INDEMNIFICATION
