The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

#### ARTICLE I

#### **CORPORATE NAME**

The name of the corporation is **DEKKERS AVIATION GROUP**, **INC.** (the "Corporation").

#### ARTICLE II

#### PRINCIPAL OFFICE
