

I. NAME

The name of the corporation is AUTO BODY TECHNICIANS, INC.

II. TERM OF EXISTENCE

This corporation shall have perpetual existence.

X. AMENDMENTS

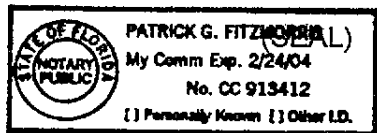




