### ARTICLES OF INCORPORATION OF IMO INTER MEDIA OUTSOURCERS, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

#### ARTICLE I NAME

The name of the corporation is IMO Inter Media Outsourcers, Inc. (hereinafter called the "Corporation").
