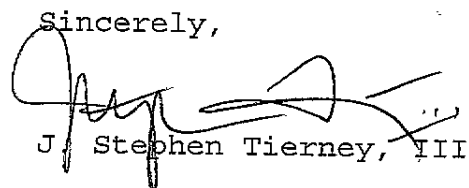

ARTICLE I - NAME

The name of the corporation is ADVANTAGE LAWN CARE AND LANDSCAPE, INC.

ARTICLE II - DURATION

This corporation shall exist perpetually commencing as of April 1, 2000.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business for which corporations may be organized under the Florida General Corporation Law.

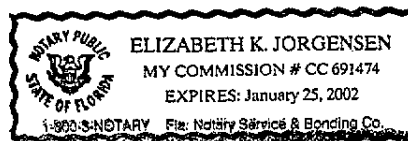

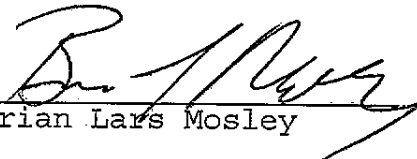
