

# ARTICLES OF INCORPORATION

ROMED PARTY SUPPLIES CORP. 116 S.W. 57th Avenue Miami Florida 33126

#### <u>ARTICLE I - NAME</u>

The name of this corporation is: ROMED PARTY SUPPLIES CORP.

# ARTICLE II - DURATION

This corporation is to exist perpetually. It shall commence its existence upon the signing of these Articles of Incorporation by the initial subscribers.

#### ARTICLE III - PURPOSE
