#### ARTICLES OF INCORPORATION

### EMPIRE PROPERTIES 1325, INC.

#### ARTICLE I - NAME AND BUSINESS ADDRESS

The name of this Corporation is Empire Properties 1325, Inc. Its principal office and mailing address is 1754 Bay Road, Miami Beach, Florida 33139.

#### ARTICLE II - DURATION

The effective date of this Corporation shall be March 17, 2000, and it shall exist perpetually thereafter unless sooner dissolved according to law.

#### ARTICLE III - PURPOSE

The purpose of this Corporation is to engage in any activities or business permitted under the Laws of the United States and the State of Florida, including, but not limited to, the purchase, sale, management and development of real property, and any marketing or promotion related thereto.

#### ARTICLE IV - CAPITAL STOCK
