ARTICLES OF INCORPORATION OF NO IDEA, INC.

SECRETARY OF STATE TALLAHASSEE, FLORIDA

Article 1

Name. The name of this Corporation is NO IDEA, INC.

<u>Article II</u>

<u>Principal Office</u>: The principal place of business shall be 2618 N.E. 18th Terrace, Gainesville, Florida, 32609, and the mailing address of this corporation shall be: Post Office Box 14636, Gainesville, Florida, 32604.

Article III

<u>Duration</u>. The period of duration of this Corporation shall be perpetual.

Article IV
