ARTICLES OF INCORPORATION

<u>OF</u>

ACTIVE MORTGAGE CORP. OF CENTRAL FLORIDA

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation:

ARTICLE I - NAME

The name of the corporation is ACTIVE MORTGAGE CORP. OF CENTRAL FLORIDA.

ARTICLE II - DURATION

The duration of the corporation is perpetual, effective on April 1, 2000.

ARTICLE III - PURPOSE

The general purposes for which the corporation is organized are:

All or any part of said capital stock may be paid for in cash, in property or in labor or services at a fair value to be fixed by the Board of Directors at a meeting called for such purpose. All stock when issued shall be paid for and shall be nonassessable.
- (2) In the election of directors of this corporation there shall be no cumulative voting of the stock entitled to vote at such election.

ARTICLE V - INITIAL REGISTERED OFFICE AND AGENT

The initial street address of the principal office of this corporation in the State of Florida will be 4164 Leafy Glade Pl., Casselberry, FL 32707. The Board of Directors may from time to time move the principal office to any other address in Florida. The name of the initial registered agent of this corporation is Michael Ciotti.

ARTICLE VI - INITIAL BOARD OF DIRECTORS

No shareholder of the corporation shall have any preemptive or preferential rights of subscription to any shares of any class of the corporation, whether now or hereafter authorized, or to any obligations convertible into shares of the corporation, issued or sold, nor any right of subscription to any thereof other than such rights, if any, and at such price as the Board of Directors, in its discretion from time to time may determine, pursuant to the authority thereby conferred by the Articles of Incorporation, and the Board of Directors may issue shares of the corporation or obligations convertible into shares without offering such issue either in whole or in part to the shareholders of the corporation, and no holder of preferred shares of the corporation shall have any preemptive or preferential right to receive any of such shares or obligations declared by way of dividend. Should the Board of Directors as to any portion of the shares of the corporation, whether now or hereafter authorized, or to any obligation convertible into shares of the corporation, offer the same to the shareholders of any class thereof, such offer shall not in any way constitute a waiver or release of the right of the Board of Directors subsequently to dispose of other portions of such shares or obligations without so offering the same to the shareholders. The acceptance of shares in the corporation shall be a waiver of

any such preemptive or preferential right which in the absence of this provision might otherwise be asserted by shareholders of the corporation or any of them.
