ARTICLES OF INCORPORATION OF

MSS MANAGEMENT INC.

ARTICLE 1 - NAME

MSS MANAGEMENT INC.


ARTICLE 12 - REGISTERED OFFICE AND REGISTERED AGENT

ARTICLE 13 - FISCAL YEAR


The fiscal year of the Corporation shall be from January 1 to December 31 of each year.
