NAME**

The name of this corporation shall be i BAY NET, INC.

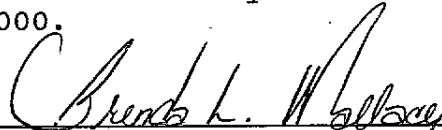

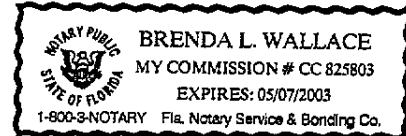
