# ARTICLES OF INCORPORATION OF

#### **ZUMBRUM-HICE ENTERPRISES, INC.**

The undersigned subscribers to the Articles of Incorporation being natural persons competent to contract, hereby form a corporation under the laws of the State of Florida.

#### ARTICLE I

#### <u>Name</u>

The name of this corporation is ZUMBRUM-HICE ENTERPRISES, INC., INC.

## ARTICLE II General Nature of Business

This corporation is organized for the purpose of transacting any and all lawful business permitted under the laws of the State of Florida.

### ARTICLE III Capital Stock

The maximum number of shares of capital stock the Corporation shall be authorized to have outstanding is 100,000 shares of Class A voting common stock with 1 mill (\$0.001) par value and 100,000 shares of Class B nonvoting common stock with 1 mill (\$0.001) par value. 
