
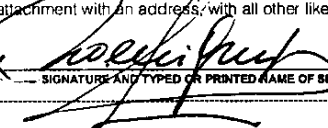

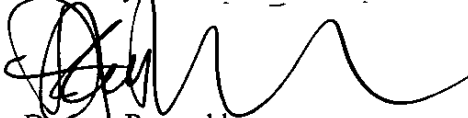
Please find enclosed the completed form and fee of \$150 to update our corporation's information.
