\$121.00 FOR 30 PILLS IN LESS THAN 5 MONTHS) THIS IS JUST ONE EXAMPLE.


I WAS DIAGNOSED A DIABETIC A YEAR AGO AND 30 AVANDIA COST \$80.00.
