**ARTICLE I - NAME**

The name of this Corporation is: AT YOUR SERVICE-McHUGH, INC.

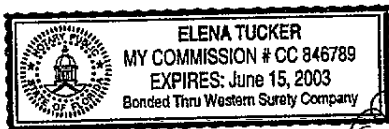
