

ARTICLES OF AMENDMENT

OF

The undersigned Corporation, in accordance with the Florida General Corporation Act and its Bylaws, hereby adopts the following Articles of Amendment:

2. Article V of the articles of incorporation of It's Your Job Now, Inc. was amended as follows:


"This Corporation is authorized to issue 1,000,000 shares of \$0.01 par value common stock."


