#### ARTICLES OF AMENDMENT

The following provisions of the Articles of Incorporation of Southern Security Finance Company, a Florida corporation, filed in the office of the Secretary of State, Tallahassee, Florida on March 17, 2000, be and they are hereby amended in the following particulars:

# A. ARTICLE IV is amended to provide as follows:

This corporation shall have an authorized issue of one thousand (1,000) shares of Common Stock of no par value and said shares shall be non-assessable and shall contain rights of preemption.

# B. ARTICLE VIII is amended to provide as follows:

Every shareholder, upon the sale for cash of any stock of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his pro-rata share thereof (as nearly as may be done without issuance of fractional shares) at the price and terms at which it is offered to others.

C. The last sentence of ARTICLE XI is amended to provide as follows:

Subject to the By-Laws, if any, adopted by the stockholders, the directors may make the By-Laws of the Corporation and provide that directors' meetings may be held without or within the State.

D. The first sentence of ARTICLE XII relating to officers, is amended to provide that the corporation shall have a president, who shall be a director, a secretary and a treasurer and one or more vice presidents.

This amendment was adopted by the action of incorporator, all of the directors and all of the shareholders on April 18, 2000.

The number of votes cast for the Amendment by the shareholders was sufficient for approval.


