ARTICLE I -- NAME

The name of this corporation is PEGGY BOWEN, CRNA PA

ARTICLE II--DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

ARTICLE III - PURPOSE


ARTICLE IX-- INDEMNIFICATION
