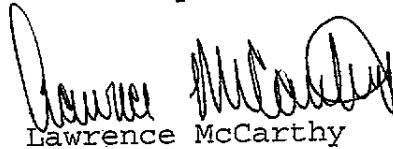

ARTICLE I. NAME

The name of this corporation is

L & S PAINTING OF BREVARD, INC.

ARTICLE II. DURATION

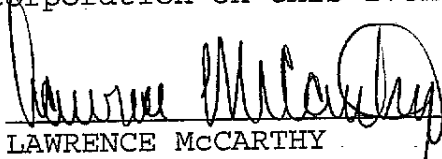

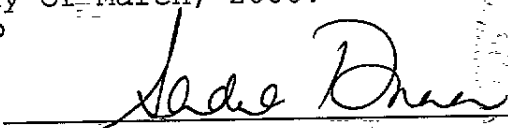

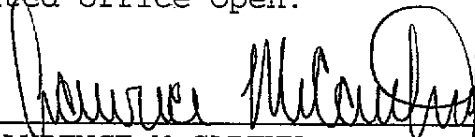
