### ARTICLES OF INCORPORATION

OF

The undersigned, acting as incorporators of the corporation under the Florida General Corporation Act, adopt the following Articles of Incorporation for such corporation.

# ARTICLE I.

The name of this corporation is

#### ARTICLE II.


