ARTICLE ONE

The name of the corporation is NANDALL SERVICES, INC. The principal office of the corporation is 6884 125TH Terrace North, Largo, Florida 33773.

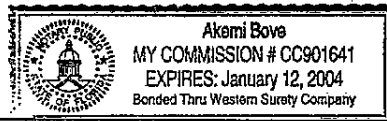
