ARTICLE I - Name

The name of this corporation is JOHN COMM LEASING INC.

ARTICLE II - Street Address and Mailing Address

The street address and mailing address of this corporation is

ARTICLE III - Duration

This corporation shall have perpetual existence.

ARTICLE IV - Purpose

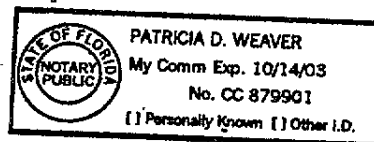
