**ARTICLES OF INCORPORATION  
OF  
CAMPBELL AIR CONDITIONING CORP.**

**ARTICLE ONE**

The name of this corporation is CAMPBELL AIR CONDITIONING CORP. and the mailing address of the corporation shall be 2603 NE 9<sup>th</sup> Avenue, Cape Coral, FL 33909.

**ARTICLE TWO**

The date of the commencement of corporate existence of the corporation shall be the date these Articles are executed.

The duration of the corporation is perpetual.

**ARTICLE FOUR**


