ARTICLES OF INCORPORATION

OF

CAMPBELL AIR CONDITIONING CORP.



ARTICLE ONE

The name of this corporation is CAMPBELL AIR CONDITIONING CORP. and the mailing address of the corporation shall be 2603 NE 9th Avenue, Cape Coral, FL 33909.

ARTICLE TWO

The date of the commencement of corporate existence of the corporation shall be the date these Articles are executed.

ARTICLE THREE

The duration of the corporation is perpetual.

ARTICLE FOUR

The general purposes for which the corporation is organized are:

- 1. To engage in the business of air conditioning installation and maintenance.
