Article I – Name

The name of this Corporation is Richard Scott and Associates, Inc.  
2927 EMBASSY DRIVE, WEST PALM BEACH FLORIDA 33401

Article II – Duration

The Corporation shall have perpetual existence.

Article III – Purpose

The Corporation may engage in any activity or business permitted under the laws of the United States and of the State of Florida.

Article IV – Capital Stock

This Corporation is authorized to issue 1000 shares of one Dollar (\$1.00) par value common stock, which shall be designated "Common Shares.

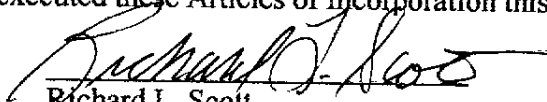
Article X – Incorporator

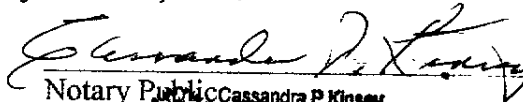
